Since 1987 she has held both clinical and executive leadership positions in the organization. She established the Weitzman Center, now known as the Weitzman Institute, in 2005 and established the country's first postgraduate NP residency program for primary care NPs in 2007. Margaret also serves as national co-director of the LEAP (Learning from Effective Ambulatory Practices) project and is the co-PI of the HRSA National Cooperative Agreement on Clinical Workforce Development.
